#### Introduction

As per Step 4 of government's plan, all measures have been lifted from 19 July 2021 for the full return of all pupils: <a href="https://www.gov.uk/government/publications/actions-for-schools-during-the-coronavirus-outbreak/schools-coronavirus-covid-19-operational-guidances.published">https://www.gov.uk/government/publications/actions-for-schools-during-the-coronavirus-outbreak/schools-coronavirus-covid-19-operational-guidances.published</a> by the Department for Education (DfE).

Schools and settings will only need to implement some, or all, of the measures in this plan in response to recommendations provided by the local authority (LA), directors of public health (DsPH), Public Health England (PHE) health protection team or the national government.

It may be necessary to implement these measures in the following circumstances:

To help manage a COVID-19 outbreak within the school / setting. Actions will need to be considered when either of the following thresholds are met: For most settings:

- There are 5 positive cases amongst pupils or staff who are likely to have mixed closely within a 10-day period
- 10% of pupils or staff who are likely to have mixed closely test positive within a 10-day period

For special schools, residential settings, and settings with 20 or fewer pupils and staff, use:

- There are 2 positive cases among pupils or staff who are likely to have mixed closely within a 10-day period
- If COVID-19 infection rates in the community are extremely high, and other measures have failed to reduce transmission
- > As part of a package of measures responding to a 'variant of concern' (VoC)
- > To prevent unsustainable pressure on the NHS

When one of the thresholds above is met, schools and settings will need to review the testing, hygiene and ventilation measures already in place.

1. Testing	
In the event of an outbreak, schools and settings will need to adhere to national guidance on the reintroduction of home testing and onsite asymptomatic testing  • If recommended, increase the use of home testing by staff.  Work with the director of public health (DPH) on any further support needed regarding testing	Greenholm Primary distributes home test kits to staff, and keeps a supply of test kits to increase distribution in case of an outbreak.
2. Face Coverings	
If recommended, pupils, staff and visitors who are not exempt from wearing a face covering:  • Should be asked to keep on or put on a face covering when arriving at school and moving around indoors in places where social distancing is difficult to maintain, such as in communal areas  And/or:	Primary Schools have been deemed exempt from mandatory face coverings.  Greenholm has a stock of face masks and face shields to deploy should the advice change.  As precaution all visitors are advised they may wear a mask if that makes them feel comfortable.



Should be asked to wear a face covering in classrooms or during activities, unless social distancing can be maintained or a face covering would impact on the ability to take part in exercise or strenuous activity	
<ul> <li>In some circumstances, transparent face coverings, which may assist communication with someone who relies on lip reading, clear sound or facial expression to communicate, can also be worn. Transparent face coverings may be effective in reducing the spread of COVID-19.</li> </ul>	
<ul> <li>Face visors or shields can be worn by those exempt from wearing a face covering but they are not an equivalent alternative in terms of source control of virus transmission.</li> </ul>	
<ul> <li>No pupil or student should be denied education on the grounds of whether they are, or are not, wearing a face covering.</li> </ul>	
3. Shielding	
In the event of an outbreak, Schools and settings will need to adhere to national guidance on the reintroduction of shielding.	School is prepared to supply materials necessary for staff to work from home, and
<ul> <li>Follow national or local guidance on the reintroduction of shielding which would apply to those on the <u>shielded</u> <u>patient list (SPL)</u>.</li> </ul>	this has been implemented previously so staff are experienced.  Remote learning software package subscription will be extended, so children can access progressive and monitored learning from home
<ul> <li>Introduce additional protective measures in school for individuals required to shield</li> </ul>	
<ul> <li>Consider home working for members of staff requiring to shield</li> </ul>	



Consider remote learning offer for pupils unable to attend school due to shielding	
4. Other Measures	
Parents, carers, pupils and staff should be informed promptly about the introduction of control measures.	School is still ensuring ventilation in classrooms and shared spaces including Offices
Pay due consideration to limiting:	Daily Touch point cleaning has been extended to ensure areas as disinfected  Distancing is still being advised where possible  School performances are being separated by Keystage to reduce pupils simultaneously in hall
Cleaning – (In addition to existing robust cleaning regimes) Following the identification of the person with COVID-19 symptoms, clean and disinfect:  • All surfaces that the symptomatic person has come into contact with, including objects which are visibly contaminated with body fluids; and  • All potentially contaminated high-contact areas such as toilets, door handles, telephones, grab-rails in corridors and stairwells	



5. Attendance Restrictions	
Attendance restrictions will only be recommended as a last resort. If recommended, implement the measures in this section:	
5.1 Eligibility to remain in school

5.2 Education and support for pupils at home	
All pupils required to stay at home will receive remote education.	Remote learning software package subscription will be extended, so children can access progressive and monitored learning from home

<ul> <li>The school will continue to provide meals or lunch parcels for pupils eligible for benefits-related free school meals while they are not attending school because of COVID-19 isolation guidelines.</li> </ul>	will not need to provide FSM for children isolating.



5.3	Wraparound care  Access to before and after-school activities and wraparound care during term time and the summer holidays will be offered to those that need it most.  Eligibility to attend will be communicated once the restrictions are confirmed.	Scl	hool will provide future wraparound care upon the request of BCC as it has done previously should future lockdowns necessitate it.
5.4	Safeguarding  Review child protection policy to make sure it reflects the local restrictions and remains effective.  Aim to have a trained DSL or deputy DSL on site wherever possible.	•	School has multiple DSL's (6x) to ensure effective continuity School has employed an inclusion worker as a DSL who monitors attendance and contacts home where necessary
•	<ul> <li>When vulnerable pupils are absent:</li> <li>Speak to parents/carers and, where appropriate, social workers and the local authority, to work out the reason for absence</li> <li>Encourage attendance</li> </ul>		
	<ul> <li>Ensure vulnerable pupils can access appropriate education and support while at home</li> <li>Maintain contact, and check regularly that the pupil is able to access remote education provision</li> </ul>
